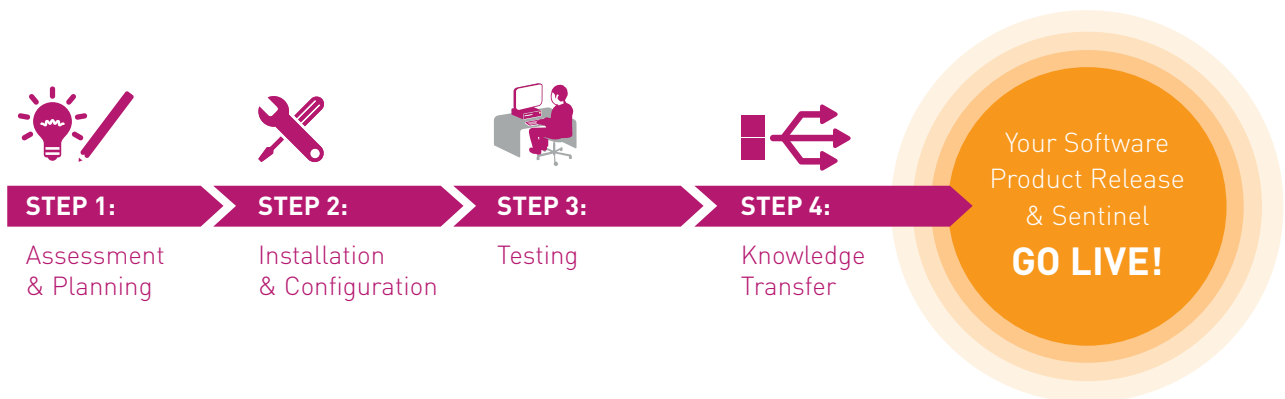

How the Sentinel JumpStart Implementation Service Works
